



# 2022 Washington Youth Tour

***A TRIP OF A LIFETIME!***

**June 16-23, 2022**

Middle Georgia EMC will select four teenagers to join dozens of other students, representing electric cooperatives across Georgia, on the Washington Youth Tour. The competition is open to all high school students who live in or attend a school in Dooly, Pulaski, or Wilcox County.

Students not living in or attending a school in the above counties are eligible if their parents are members of Middle Georgia EMC and live within the cooperative's service area. The cooperative's service area is Dooly, Ben Hill, Houston, Macon, Pulaski, Turner, and Wilcox counties. The tour begins with a banquet for participants and their parents. Then the students enjoy a day of activities in their home state before flying to Washington, D.C., for an incredible week in our nation's capital. Once they are in Washington, they will have the opportunity to meet Youth Tour students from all across the nation.

## **ELIGIBILITY:**

1. Be a sophomore, junior, or senior in good standing with your school
2. The applicant must be 16 years of age by June 16, 2022
3. Must have parent's consent

## **HOW TO APPLY:**

All that is required to enter is for the student to **complete the attached application form, provide two letters of recommendation, and submit the essay by March 1, 2022.** (*See Essay Topic and Information Section*). Be sure to provide all of the information requested.

## **RECOMMENDATIONS:**

Please have two faculty members or administrators from your present school (counselor, teacher, principal, or assistant principal) comment as to why you should be considered as a Youth Tour delegate.

## **THE SELECTION OF DELEGATES**

The deadline to apply for the Washington Youth Tour is **Tuesday, March 1, 2022.** The application and essay will be judged by Youth Tour Coordinators from other EMC's across Georgia. Once Judging is completed students who are chosen as finalists will be invited for an interview. ***The interviews will be held beginning at 10:00 am on Thursday morning March 17, 2022.*** A panel of judges comprised of Youth Tour Coordinators from other EMC's will conduct the interviews. Interview questions will be general questions about the student. The students will also be tested on their knowledge of Rural Electrification and the history of Middle Georgia EMC at this time. The final selection of our delegates is determined by the combined scores of the application and essay, test and interview process.

In order to enter the contest you are required to write an essay on the following topic:

Here is what you need to do:

1. Type an essay 300 to 600 words in length, double-spaced on 8.5 x 11 bonded paper.
2. A Middle Georgia EMC representative will pick up the application and essay at the counselor’s office or the main office of your school on **March 1st** or you can return them to the offices of **Middle Georgia EMC** located in Hawkinsville, Vienna and Rochelle by **Monday March 1, 2022 no later than 9 a.m. Please do not mail the application and essay!**

Please remember to include the completed application and two letters of recommendation with your essay. The finalist will be contacted once judging of the applications and essays has been completed. Good luck on your essay!

# Washington Youth Tour Information

The Washington Youth Tour, the state's oldest youth leadership program, was created from extemporaneous comments made by then-Senator Lyndon Johnson as he addressed the National Rural Electric Cooperative Association (NRECA) Annual Meeting in Chicago in 1957. "If one thing goes out of this meeting," the Senator declared, "I hope it will be sending youngsters to the national capitol where they can actually see what the flag stands for and represents." Beginning that year, some of the Texas Electric Cooperatives sent groups of young people to Washington, D.C. to work during the summer in Senator Johnson's office to learn about government in action.

Middle Georgia EMC will be sending four high school students from our service area on this exciting, all-expenses paid trip to Washington, D.C. These four teenagers will join dozens of students from other electric cooperatives in Georgia to represent our state in the Washington Youth Tour, an annual event that brings more than 1,500 young people from across the country to our nation's capital.

Youth Tour events for Georgia's participants will begin with a kickoff banquet for the students and their parents in Atlanta. That will be followed by a day full of activities for the Georgia students before they fly to Washington. Youth Tour highlights typically include visiting the U.S. Capitol, Holocaust Museum, Smithsonian Institution, U.S. Supreme Court, and whenever possible, the White House. Other stops could include the National Cathedral and Arlington Cemetery as well as the World War II, Korean War, and Vietnam War memorials and the Lincoln, Jefferson and FDR memorials. The students are also treated to a riverboat cruise on the Potomac, always a popular event.

In addition, students will have the opportunity to meet state and national leaders and gain a better understanding of how our government works. Participants will also be involved in leadership-building activities and will have the opportunity to interact with students from across Georgia and across the United States.

The Youth Tour is fun, fast-paced, well-organized and packed full of activities. The tour director is an employee of our statewide organization, Georgia EMC. They do a terrific job of planning and organizing the entire trip. Several EMC employees and their spouses from across the state volunteer to serve as chaperones. Two teacher chaperones are chosen each year as well.



## 2022 Washington Youth Tour

### *What we expect of you!*

If you are selected by your sponsoring EMC to join the Youth Tour it is because you have measured up to the highest standards of leadership and behavior. You will be representing your local EMC, all the EMCs of Georgia, your local community and the State of Georgia from the kick-off banquet to the return flight home. You will have a responsibility to yourself and others to meet the following expectations.

1. **Have a positive attitude. Remain flexible.** The nature of travel by bus and plane, combined with the size of our group, will mean constant adjustments. How you react to challenges such as possible luggage delays, long lines or rainy weather will have a lot to do with what this experience will mean to you in the end. Remember, no matter what happens, you choose the quality of your days.
2. **Wear a watch, keep your itinerary with you and be punctual.** The schedule is super-tight as we want to experience as much as we can. Know when and where you are supposed to be and show up on time! Cell phones are not permitted during touring so you cannot rely on your phone for the time. ***Bring a watch and wear it.***
3. **Participate in all planned activities.** No one may leave the group at any time unless authorized by the Tour Director. Participants will always travel/sightsee in groups of three or more. No participant may travel/sightsee by him/herself.
4. **Adhere to the dress code and wear your name badge** at all times during the Youth Tour. Your name badge is your ticket to meals and events. Participants without a name badge will be asked to retrieve it, participants in inappropriate clothing will be asked to change.
5. **Be in your hotel room by curfew each night.** Do not leave your room after this hour except with permission of your chaperone. Room checks are made each night.
6. **Respect the rights of others.** You will share a room with two other Youth Tour delegates, and will be expected to be tolerant of differences. After curfew, you will be expected to stay in your room, be ready for bed and reasonably quiet so others may sleep.
7. **Delegates may not enter the hotel rooms of delegates of the opposite sex.** Public displays of affection and physical relationships are not acceptable behavior.
8. **Remain at the hotel at all times** except when you are participating in planned activities. You may not leave the hotel to shop or visit relatives or friends in the area.
9. **Treat hotel property with care.** Any damage will result in complete payment of damage on your part, and an immediate trip home.
10. **Tobacco products, drugs, and alcoholic beverages are strictly prohibited.**
11. **The cost of long distance telephone calls is each delegate's personal responsibility.** Students must call collector use a calling card or credit card. Delegates may also bring cell phones, but cell phone use is not permitted during the touring day. You are on this trip to meet and interact with new people and see new places, so plan on talking with friends and family about your experiences before or after each day's tours.

***Infraction of these rules governing the conduct of Youth Tour delegates will be considered cause for terminating your participation. You will be sent home at your family's expense.***



## GEORGIA EMC COVID-19 POLICIES

**Policy:** The safety of all who attend the Georgia Washington Youth Tour (WYT) is of paramount importance to the Georgia EMC staff, local electric cooperative members, and the Georgia EMC (GEMC) Board of Directors. We are looking forward to being with those of you who attend the Georgia WYT in 2022.

The Georgia WYT has put in place preventative measures to reduce the spread of COVID-19; however, the Georgia WYT cannot guarantee that attendees will not become infected with COVID-19. Attending the Georgia WYT could increase any attendee's risk of contracting COVID-19.

We all assume some risk related to exposure to COVID-19 and any other communicable diseases where people are present. The Georgia WYT and our host facilities will meet all local and state requirements. Items in this document are being put into place to mitigate those risks to the best of our abilities. It remains that some of the items in this document are subject to change as we get closer to the summer. We will continue to update our procedures in cooperation with CDC guidance, our host facilities and local authorities as needed.

**Goal:** No COVID-19 infections within our group.

**Expectation:** If we have an infection, have a plan we can implement immediately.

### **Our Pledge:**

Communicate the expectations with cooperatives, parents and students before the trip.

We will follow current local and CDC rules and guidelines, as well as any additional National Rural Electric Cooperative Association (NRECA, the national association that partners with states to host the Washington Youth Tour), hotel and venue mandates.

We will require all participants to submit proof of a negative COVID-19 viral test (regardless of vaccination status) taken 48 hours or less before departure.

We will require all chaperones to be fully vaccinated. This is not a political statement or concern; we need to take all precautions available to stay fully staffed during the Youth Tour.

We will encourage, but not require, all students to be vaccinated. GEMC reserves the right to require delegates to be fully vaccinated before participating if key tour destinations, hotels, airlines, travel companies or other critical entities begin to require full vaccination for entry or use while on the WYT. We will take daily temperatures.

We will communicate any positive COVID-19 cases with parents, students, NRECA, GEMC and the local cooperative (while staying HIPAA compliant) Note: vaccination status will be asked for in the health forms to collect information pertinent to percentages necessitating mask mandates, etc.

We will seek medical treatment when appropriate.

**On the Trip:**

If the student is not feeling well, they should not attend.

We will be following current local and CDC rules (likely wearing masks while in buildings or in other areas where social distancing isn't possible or practical).

If the student has seasonal or other histamine-producing allergies, make sure that they are taking their allergy medicine prior to leaving for D.C., and while on the trip, to avoid any allergy symptoms that may be construed as COVID-19 symptoms.

Quarantine rooms will be available, and we will test anyone experiencing symptoms.

If negative, delegate will resume the trip with approval from a medical professional.

If positive, delegate will be quarantined and parents/guardian, the local cooperative and NRECA will be contacted.

Roommates and those in the immediate social/travel group, and anyone else the Georgia WYT staff deems necessary, will be tested.

Delegates with mild symptoms will have their local cooperative contacted to discuss the logistics of returning the delegate to Georgia.

Delegates with more severe symptoms will remain at the hotel until they can travel, and return logistics will be discussed with their parents and the local cooperative.

**After the Trip:**

Any student who tests positive within 7 days of returning from the trip should report this to the Georgia WYT Director who will in-turn report it to anyone in the student's immediate social/travel group and NRECA.
