CHARACTER OF SERVICE

Single-phase, 60 hertz, at available voltages

MONTHLY RATE

Base Charge: \$30.00*

Energy Charge: \$0.155 per KWH

MINIMUM MONTHLY CHARGE

The minimum monthly charge shall be the Base Charge.

Single or three-phase, 60 hertz, at available voltages

MONTHLY RATE

Base Charge: \$35.00*

Energy Charge: \$0.2200

MINIMUM MONTHLY CHARGE

The minimum monthly charge shall be the Base Charge.

POWER COST ADJUSTMENT

The amount calculated at the above rate is subject to increase or decrease under the provisions of the Cooperative's Power Cost Adjustment Clause.

Applicable to all consumers for all uses subject to the established rules and regulations of the Cooperative. Limited to loads requiring over 50 KVA of transformer capacity. In addition, non-metered cable amplifiers and other similar non-metered loads shall be billed under this schedule.

CHARACTER OF SERVICE

Single or three-phase, 60 hertz, at available voltages

MONTHLY RATE

Base Charge: \$60.00*

Demand Charge: \$6.00 per KW of Billing Demand**

Energy Charge: \$0.1385 per KWH

DETERMINATION OF BILLING DEMAND

The billing demand is based on the peak demand during the current month and the preceding 11 months and is higher of the following:

1. 100% of the current month demand
2. 90% of the previous summer month demand
3. 65% of a previous winter month demand

For the months of October through May:

1. 90% of the previous summer month demand
2. 65% of the current or previous winter month demand

Single or three-phase, 60 hertz, at available voltages

MONTHLY RATE

Base Charge: \$180 (June through September only)*

Off Peak Energy Charges:

- First 100 KWH \$0.000 per KWH
- Additional KWH \$0.1575 per KWH

On Peak Energy Charges

All KWH \$0.80 per KWH

MINIMUM CHARGE

The minimum charge shall be the Base Charge.

POWER COST ADJUSTMENT

Application to outdoor lighting by light emitting diode (LED) or high-pressure sodium (HPS) fixtures and poles conforming to Cooperative specifications. Service will be rendered only at a location that, solely in the opinion of the Cooperative, is readily accessible for maintenance.

CHARACTER OF SERVICE

Single or three-phase, 60 hertz, at available voltage

MONTHLY RATE*

Description	Effective Lumens*	Charge
Small (e.g., 100 Watt HPS)	Less than 7,000	\$10.00
Medium (e.g., 250 or 400Watt HPS)	7,000 – 25,000	\$19.00
Large (e.g., 1000 Watt HPS)	Greater than 25,000	\$38.00

*Effective Lumen output takes into consideration electrical and real-world losses (ex. thermal, optical, and assembly), so it is a better representation of the useful visible light that is actually produced.

DECORATIVE POLE INSTALLATIONS

Decorative poles are those that are constructed of fiberglass or aluminum material or require special features. All decorative pole installations shall be billed an additional \$4.00 per pole. New Lighting Projects may have an adder per light based on market and labor charges.

*The Monthly Rate will increase \$.50 per month, annually, beginning April 1, 2026, for a ten-year period.

In compliance with cooperative principles and the Corporation's bylaws, revenue received, which is more than operating cost and expenses, is patronage capital. All monies more than the cost of providing electric service are capital, at the moment of receipt, and will be credited to each patron's individual capital account.

AVAILABILITY

Available to New Schools served by Cooperative who first take service on or after March 21, 2017 subject to Cooperative's established Service Rules and Regulations and subject to the execution of a contract for service mutually agreed upon by Cooperative and the member.

APPLICABLE

Applicable to consumers without a currently effective agreement for service on another rate schedule having a maximum load of 900 KW or more at one standard voltage required on the member's premises, delivered at one point, and metered at or compensated to that voltage.

TYPE OF SERVICE

Service shall be provided as set forth in the contract for service between Cooperative and the consumer.

MONTHLY RATE

Base Charge:	\$1,000.00
Energy Charge:	\$0.0850 per KWH
Demand Charge:	\$10.00 per KW of billing demand

Schedule WPCA Wholesale Power Cost Adjustment

Applicability

This schedule is applicable to all rate schedules containing a Wholesale Power Cost Adjustment clause.

Calculation

The monthly bill computed under the Monthly Rate shall be increased or decreased by multiplying the KWH sold by the factor (WPCA) calculated in accordance with the formula shown below.

$$\text{WPCA} = (\text{PC} / \text{E}) - .0800$$

WHERE:

WPCA = Wholesale Power Cost Adjustment

PC = Total system purchased power cost from all of the Cooperative's suppliers and total cost associated with Cooperative owned generation

E = Total system KWH sold

For the purpose of calculating the WPCA, the Cooperative will seek to levelized the WPCA factor over the course of a calendar year based on actual monthly data (for prior months during the calendar year) and estimated monthly data (for remaining months during the calendar year).

As necessary, the Board of Directors shall adjust the WPCA factor to properly track and recover purchase power expense. Further, the Cooperative will track the over and under collection of purchased power expense associated with the clause and any differences at the end of the calendar year may be collected or credited the following year.
